## Public Works, Solid Waste, Highways, Parking, Water, Sewer

The Wellsboro Municipal Authority was awarded a Pennyest Grant in the amount of \$1,024,000.00 and a loan of \$108,100.00 for the UV Disinfection System Project.

Wellsboro Borough has been rewarded a Dirt & Gravel Road Grant for a stormwater project on upper Meade Street to be completed this year.

Construction for the Banik Well Transmission Line Project has begun. Estimated to take 3-4 months to complete.

## Parks & Recreation, Trees, Beautification, Senior Center

Councilor Prevost made a motion to approve the proposal for assessment services and core boring from Aquatic Facility Design, Inc. The motion was seconded by Councilor West and carried.
