# Wellsboro Borough Council Meeting Minutes January 2, 2018

Mayor John E. Wheler called the reorganization meeting to order at 6:00 p.m. in the Council Meeting Room of the Borough Office at 14 Crafton Street and the Pledge of Allegiance was recited.

Attending were Mayor John E. Wheeler, Council Members Michael J. Wood, John Sticklin, Mike Hummel, Terry L. Bryant, Borough Manager Scot F. Boyce, Jr., Chief James Bodine, and Secretary/Treasurer Susan L. Keck. Council Member elect Matt DeCamp and Craig West were also in attendance.

Mayor Wheeler performed the Swearing in of Newly Elected Council Members: John Sticklin for a 4 year term, Craig West for a 4 year term, Matthew DeCamp for a 4 year term, and Michael Hummel for a 2 year term.

Nomination and Election of Council President

Councilor Bryant nominated Mike Hummel for Council President. Councilor Wood seconded the motion. Craig West nominated John Sticklin for Council President. Councilor Wood seconded the motion. A roll call vote was called for on the first motion for Mike Hummel for Council President:

Mike Hummel elected as Council President by vote of 4 to 3.

### General Government, Administration, Buildings, Personnel

Councilor Bryant made a motion to ratify and approve accounts payable for all accounts. Councilor Wood seconded the motion and it carried unanimously.

Councilor Bryant made a motion to approve the Treasurers Report for November, 2017. Councilor Wood seconded the motion and it carried unanimously.

Councilor Bryant made a motion to approve a change in the Central Business Zoning District to allow animal hospital as a Conditional Land Use to be approved by Borough Council. Councilor Sticklin seconded the motion and it carried unanimously.

Councilor Bryant made a motion to approve the Borough Manager and Solicitor to move forward with taking the failure of compliance of Property Maintenance Code at the Pierce residence at 15 American Street and the failure to pay the original judgement to the Tioga County District Justice Office.
