	Mayor's Report Police Report- Five officers have completed toxilizer training. This unit is now in service. Chief Bodine has had verbal confirmation of a grant from Shell for a unit for breaching doors that will defeat door locking mechanisms, and a radar trailer for speed enforcement for countywide usage.
	Public Works, Solid Waste, Highways, Parking, Water, Sewer
	The Eberenz Street Bridge replacement is complete, the Borough crew only lacks final cleanup to complete the project. A guardrail and hand rail will be installed later this month.
	The Wellsboro Parking Authority has set free parking in the Borough from November 17 <sup>th</sup> , 2017 to January 2 <sup>nd</sup> , 2018.
	Glenn O. Hawbaker, Inc. has completed the paving work on Pierce Street, Sherwood Street, Wetmore Street, Antrim Street, and Prospect Street. The project was bid at \$148,053.80 and came in at a much lower cost; \$124,634.82.
7	Councilor Wood made a motion to authorize the Solicitor's Office and Borough Manager to enforce the ordinance requiring hookup to public sewer and public water, where available, and to act on the Borough's behalf, and provide signatures when needed on behalf of Wellsboro Borough. Councilor Bryant seconded the motion and it carried.

	Parks & Recreation, Trees, Beautification, Senior Center
	Councilor Sticklin made a motion to approve the closing of Central Avenue between Main Street and Water Street from 3pm to 8pm on Sunday, October 22 for the October Block Party by the Vineyard Church of Wellsboro. Council Wood seconded the motion and it carried.
	The Halloween Parade will be on October 28 <sup>th</sup> at 5:30 PM beginning at Packer Park. Trick or Treat will run after the parade until 8 PM.
