Council President Joan Hart called the Regular meeting to order and the Pledge of Allegiance was recited.

MINUTES: Minutes of the January 14, 2012 Council Meeting were approved by a motion made by Councilor Bryant, seconded by Councilor Wheeler, and carried unanimously.

OLD BUSINESS: Manager Strausser explained the HARB's recommendation was to approve the Conditional Use Request of the Hospital to demolish 38 Central Avenue and replace it with a parking lot. The vote passed 4-3. Councilor Bryant made the motion to approve, Councilor Scharf seconded it, and it carried. The proposed design for the front of the new Borough Building was also recommended for approval by a motion of Councilor Wood, seconded by Councilor Wheeler, and carried unanimously. Included in this motion was that the signage for the current State Store would be detachable and the responsibility of the renter.

General Government, Administration, Buildings, Personnel

Councilor Sticklin made a motion to pay bills for 1/16, 1/24, 1/30 & 2/7 as presented. This was seconded by Councilor Wood, carried 6-0.

HOFFMAN REMOVAL RATIFIED-Councilor Wood made a motion to ratify the removal of Duane Hoffman as a borough employee effective January 15, 2013. This was seconded by Councilor Bryant, carried 6-0.

OUTDOOR ADVERTISING ORDINANCE-Scharf made a motion to advertise an ordinance for Outdoor advertising along Route 6 for the PA Route 6 By-way proposal. This was seconded by Councilor Wood, carried 6-0.

WHEATLEY HIRED-Councilor Wheeler made a motion to hire Cole Wheatley as a laborer. This was seconded by Councilor Scharf, carried 6-0.
