NEW BUSINESS
HARB Chairman Andrew Harding detailed the HARB submissions and recommendations to Council.
Deane Center: Councilor Sticklin made a motion to approve the addition of black gooseneck lighting lamps shining toward the sidewalk and up-lighting to be between a 3000 to a 3500 range and not exceed the top cornice of the building. Councilor Scharf seconded the motion and it carried.
County of Tioga: Councilor Connelly made a motion to approve the Tioga County Jail Building Exterior Restoration: repointing and reworking brick, repairing and replacing damaged material, windows, columns, and chimney using matching brick and grout, and replacing the double front door with a single door of the same width as presented. Councilor Wood seconded the motion and it carried. County of Tioga: Councilor Wood made a motion to approve the Tioga County Courthouse
security area entry and new Annex Addition. Councilor Wood seconded the motion and it carried.
Street Loan Ordinance - Ordinance # 679 was adopted by motion of Councilor Sticklin, seconded by Council Wood and carried unanimously.
Flood Plain Ordinance Review- The most recent ordinance was sent to FEMA for their review The ordinance has to be in place by June. Councilor Connelly made a motion to authorize the Borough manager to advertise it when it has been approved by FEMA. Councilor Mase Updyke seconded the motion and it carried.
Hamilton Gibson- A motion was made to approve the placement of pianos on the sidewalks again this year by Councilor Wood, seconded by Councilor Sticklin, and carried unanimously.
