- 1. County of Tioga, 118 Main Street, Tioga County Courthouse and Annex Additions and Improvements Project- Revisions to windows and entry ramp. The Board would prefer six windows on the Annex Addition. Joan Hart made a motion to have the architect insert six windows if they would fit. Of the six, four should be spandrel. If only four windows would fit, then two would need to be spandrel, with the intent of matching the existing spacing on the west end of the building. This motion was seconded by Teresa Capuzzo, and carried unanimously. The spandrel glass, which is a durable glass used to cover construction materials, will help create an overall uniform appearance.

- 2. County of Tioga, 118 Main Street, Tioga County Courthouse and Annex Additions and Improvements Project- Front porch railing, pillars, light posts (with single lights) were all discussed. With the exception of a final railing specification (spindle type) to be submitted by Marc Rice, all above changes were recommended for approval by motion of Jay Erb, seconded by Joan Hart, and carried unanimously
