Council President Joan Hart called the Regular meeting to order and the Pledge of Allegiance was recited.

MINUTES: Minutes of March 11, 2013 meeting were approved by a motion made by John Wheeler, seconded by Rudy Scharf, and carried unanimously.

EXECUTIVE SESSION: Council did hold an Executive session on a Police personnel matter on March 14, 2013.

HARB- St Peter's Catholic Church proposed to enclose a side porch and add a railing to match the existing stoop at their new Rectory at 47 Central Avenue. The scroll work will be incorporated in the new hand rail. Councilor Wood made a motion to accept HARB's recommendation to approve. Councilor Wheeler seconded the motion, and it carried unanimously.

The Laurel Health Water Street/Queen Street parking lot addition will now incorporate 10' x 20' parking spots. Motion to approve the addition contingent on the Shade Tree Commission recommending type of trees was made by Councilor Bryant, seconded by Councilor Wood, and carried.

Minor subdivision for Quarry Lot property. A motion was made by Councilor Scharf, seconded by Councilor Wood to approve the subdivision. This carried unanimously.

Zoning Hearing for a non-conforming lot. The Planning Commission tabled this matter until their next meeting in April. Council did not make a motion on this matter, preferring to have the Zoning Hearing Board consider it.

Leukemia and Lymphoma Awareness Walk Saturday, July 20, 2013- This was approved by motion of Councilor Wood, seconded by Councilor Wheeler, and carried.

A motion to pay bills for 3-21, 3-27, and 4-4 was made by Councilor Wood, seconded by Councilor Wheeler, and carried unanimously.

CHANGE ORDERS- 14 CRAFTON STREET-A motion to approve Change Order #1 in the amount of \$34,083.70 and Change Order #2 in the amount of \$7,114.00 for the new office contract was made by Councilor Bryant, seconded by Councilor Wood, and carried unanimously.

King Street Bridge is currently being bid by the state.

The Membrane Water Filter plant is proceeding along as planned. We still anticipate it will be on line in June of this year.
