OLD BUSINESS

Councilor Sticklin made a motion to appoint Dave Cleveland to the unexpired term of Airport Board member Dave Lamphier. Councilor Connelly seconded the motion and it carried. A roll call vote was requested.

Strausser as Flood Plain Administrator and Susan L. Keck, Assistant Zoning Officer, as Assistant Flood Plain Administrator. Councilor Sticklin seconded the motion and it carried.

Councilor Scharf made a motion to approve JH Williams three year proposal for auditing the borough funds for \$14,700.00 for 2015, \$14,800.00 for 2016, and \$14,900.00 for 2017. This will cover 2015, 2016 and 2017 audits. The Wellsboro Municipal Authority Audit would be \$4,200.00 for 2015, \$4,300.00 for 2016 and \$4,400.00 for 2017. Police Report- The Chief explained that DUI's are on the rise right now.

Public Works, Solid Waste, Highways, Parking, Water, Sewer

We will be issuing a change order for the street program. Sherwood Street will have the gas line replaced next year. We will not repave this street this year. The Street Committee will meet on May 28th.

We received an honorable mention award for the King Street bridge at the PA State Association of Borough's (PSAB) conference in April. It was presented by PennDOT's and PSAB.

Parks & Recreation, Trees, Beautification, Senior Center

Councilor Sticklin made a motion to award the Pool Feasibility Study to MKSD Architects, Allentown, PA for \$42,080.00. The funds will be from General Rainy Day Recreation Fund, the General Fund and \$5,000 from Etner Foundation and \$5,000 from Patterson Foundation. Councilor Connelly seconded the motion and it carried.

Councilor Sticklin made a motion to approve the Keystone Kops, Relay for Life Team's request to hold a block party on Friday, August 7th from 4 PM to 8 PM and close Central Ave from Main St to Water Street. Councilor Connelly seconded the motion and it carried.
