Minutes of the May 13, 2019 Council Meeting- Councilor Sticklin made a motion to approve the minutes. Councilor Prevost seconded the motion and it carried.

Public Comments on Agenda Items – Mike Lundgren presented two petitions against the proposed no parking zone on Pearl Street. They would like two spots exempted from the proposal; the spaces above Charles on Pearl Street.

Chief Bodine explained the reasons for the proposed change; One, multiple accidents at the Norris Street intersection. Two, this is a secondary detour route for truck traffic. Sight distance is greatly reduced when vehicles are parked on the street.

Councilor Yacovissi made a motion to adopt Resolution 2019-02, Resolution for Plan Revision for New Land Development, for Ward Baker Subdivision. Councilor Sticklin seconded the motion and it carried.

Councilor Yacovissi made a motion to accept the resignation of Rudolf K. Scharf from the Wellsboro Planning Commission. Any resident interested in serving on the Planning Commission should notify the Borough Manager in writing by July 26th, 2019. Councilor Sticklin seconded the motion and it carried.

Motion to adopt Ordinance #693, adding no parking zones to Water Street (from Norris Street for 343 feet to the northeast along the southeastern side of the street; and Pearl Street (between Charles Street and King Street on the southeastern side of the street). There was no action taken on this motion.

Councilor Sticklin made a motion to approve the attached list of 2019 Life Guards for the Packer Park Pool. Councilor Prevost seconded the motion and it carried.
