Safety, Police, Fire, Protective Inspections, Codes, EMA

MAYOR'S REPORT: The Civil Service test was May 30, more testing will be held on 12 June. The P.D. is ready for the June events.

Police Report: Many thefts and burglaries have occurred lately, and several DUI's. The Chief completed Penn State Advanced Executive Training Course, Officer Deveney completed the Background Investigation School, Officer Boyce completed Confidential Informant Management School, and Officer Levindosky is currently attending the FBI Hostage Negotiation School.

A Grant has been awarded to the Department from the National Association of Drug Diversion Investigators for a prescription drug drop box. This would be available to the public 24 hours.

Chief Bodine began an anti-bullying campaign at the schools this spring.

The Chief also spread the word about STING, a program which will award kids tickets for observed good behavior. The tickets will be worth an ice cream cone at Peggy's Candy's.

Our Municipal Authority has agreed to fund the painting of all fire hydrants.
