MAYOR'S REPORT

Police Report- The Chief worked with Williamsport PD testing drugs for them and networking with them on results. The Tahoe cage is inbound and waiting for installation. The Breathalyzer will be coming in and training completed. The officers will be certified in the operation of this. The testing of breath instead of drawing blood is now the preferred method.

Public Works, Solid Waste, Highways, Parking, Water, Sewer

The Sears Street and Eberenz Street box culverts are ordered.

Wellsboro Electric has completed replacing the necessary utility poles in Brownlee (11 total). We received the invoice today and that will be paid with Gas Royalties.

Parks & Recreation, Trees, Beautification, Senior Center

Councilor Sticklin made a motion to close Charles Street on August 12th from 7 AM to 5 PM from Pearl Street to Main Street for a Hometown Science Festival on the Green. This is being sponsored by the Tioga County Conservation District. Councilor Hummel seconded the motion and it carried.

Employee Benefits, Negotiations, Insurance, Safety, Training

Other Business- Dan Strausser read a highlight review of what has been accomplished together: A new water filter plant, replacement of 8 bridges counting the two for this year, completed the Joint Comprehensive Plan, completed a Parking Study, started a quarterly Borough newsletter at no cost to the Borough, street improvements of well over one million dollars have been completed, several thousand feet of storm drainage installed and/or replaced, a new Borough Office and Police Office, the Woodland Park Master Plan, upgraded vehicles and equipment for DPW and Police, completed water, sewer and storm drainage interactive GIS mapping, the Municipal Authority is continuing to update and improve our water and sewer systems, we have secured 3.5 million in gas leases for water and sewer, Approximately \$600,000 in gas royalties to date for water and sewer, \$1.6 million in grants to the borough, and we have lowered our debt by approximately, \$1.75 million.
