NEW BUSINESS -

Sealed bids were open at 5:00pm March 10th, 2025 at a public meeting held at 14 Crafton Street for materials required to complete the Meade Street Dirt & Gravel project.

Councilor Henry made a motion to accept the low bid of \$69,540 from Ianson Farms LLC for 1,520 tons of DSA (supplied and applied by contractor). The motion was seconded by Councilor Smith and carried.

Councilor Prevost made a motion to accept the low bids of \$16.95/ton for Subbase No. 2A and \$13.20/ton for Crushed Shale/4- from DeCristo, Inc. The motion was seconded by Councilor Wood and carried.

HARB-

Councilor Pearson made a motion to approve C&N Bank exterior improvements at 90-92 Main Street with the understanding that all wood elements upon replacement are as close as possible to the original structures. The motion was seconded by Councilor Prevost and carried. Councilor DeCamp abstained from the vote due to a conflict of interest.

Councilor Pearson made a motion to approve Hodrick Realty signage for 98 Main Street as presented. The motion was seconded by Councilor Prevost and carried.

HERA Registry Discussion – After discussion, it was determined that the 1993 BOCA that was adopted by Council addresses vacant properties that become blights on the community and also gives the Code Enforcement Officer the authority to write citations for violations related to blight concerns. The General Government Committee will be developing a standard operating procedure for the Code Enforcement Officer to use when determining blight and if citations will be written.

Councilor Smith made a motion to approve PALCO Federal Credit Union's commercial remodel with the addition of a drive-thru, as recommended by the Wellsboro Planning Commission. The motion was seconded by Councilor Prevost and carried.
